- 1. Platinum CUSIP Number: A unique, nine-character identification number assigned by the Committee on Uniform Securities Identification Procedures to each publicly traded security at the time of issuance.
- 2. Platinum Pool ID: The Ginnie Mae Pool identifier; the number assigned to the Platinum pool by Ginnie Mae at pooling.
- 3. Platinum Pool Indicator: The one-character value identifying the Issue Type of the given Platinum pool (X, C, H, or M).

- 4. Platinum Pool Type: The two-character value identifying the pool type of Platinum pool.
- 5. Record Type: "J" for the Platinum Collateral record.
- 6. Pool ID: The Ginnie Mae Pool identifier for the Collateral pool; the number assigned to the pool by Ginnie Mae at pooling.
- 7. Pool Indicator: The one-character Issue Type for the Collateral pool (X, C, H, or M).
- 8. Pool Type: The two-character pool type for the Collateral pool.
- 9. Issuer Number: The four digit identifier for the Collateral pool's issuer. This is the issuer as of the time of Collateral pool issuance. Field will be blank for Multiple Issuer Pools and Platinum Pools.
- 10. Issue Date: The Pool Issue Date of the Collateral pool.
- 11. Maturity Date: The Pool Maturity Date of the Collateral pool.
- 12. Interest Rate: The Pool Interest Rate of the Collateral pool at the time of Collateral pool issuance.
- 13. Face Amount in Platinum Pool: The Face Amount of the Collateral pool in the Platinum Pool. This is the amount at pooling (of the Platinum Pool).
- 14. Percentage of Pool in Platinum Pool (At Issuance): The percentage of the Collateral pool included in the Platinum Pool. This is the percentage at pooling (of the Platinum Pool). This percentage will not change while in the Platinum Pool.
- 15. Active Pool Flag (Active or Terminated): The Indicator of whether the Collateral pool status is active or terminated.
- 16. As-Of Date (CCYYMM): Reporting period for the data.
- 17. Current Month Amount in Platinum Pool: The current month amount in the Platinum Pool for each Collateral pool.
- 18. Percentage of Platinum Pool (Current Month): The percentage of the Platinum Pool for each Collateral pool.
