Version 1.0.1	06/10/2020 Initial Version, revised to change the order of Items 3 and 4 in the “F” record (now Disclosure Sequence Number precedes Issuer ID). The overall length of 48 remains unchanged.
Version 1.1	First Quarter 2021 Version 1.0.1 updated with revised definitions for “Forbearance Exit Codes” (“F” Record, Item 9). There are no layout changes in Version 1.1 compared to Version 1.0.1.

README NOTE: The Supplemental File of forbearance loan records is a file that “parallels” the current Ginnie Mae MBS Loan Level Disclosure Version 1.7 in terms of the file format. The loan record in this Supplemental file is a “short” record, the “F” record. It has the same primary key fields of Issuer ID, Pool ID, and Disclosure Sequence Number, as the current MBS Loan Level Disclosure file. The Disclosure Sequence Number in the Supplemental File is the same sequence number used in the MBS Loan Level Disclosure file and can be used to match or link the records in the Supplemental file to the corresponding records in the current MBS Loan Level Disclosure File (V1.7).

**Summary of the Record Types in the File.**

**Organization of Records within the File—Sorted by Pool Record then Loan Records in the Pool. All loan records for a pool occur together in the file; then the next pool with its loan records; and so on.**

**LAYOUT NOTES:**

- (1) This document provides the layout and specification for supplemental disclosure of loan forbearance status.
  - a. Forbearance Supplemental Loan records are disclosed for those active loans where the issuer has reported borrower payment forbearance for the loan.
  - b. Loans liquidated in the Report Period, and having a forbearance report, are also included in the supplemental file.
  - c. The data in the file is based on monthly loan level forbearance reporting by Ginnie Mae issuers. This data supplements the existing loan level reporting.
- (2) All records/fields are fixed length.
- (3) The record order of the file is as follows:
  - a. File Header, 1<sup>st</sup> Record in the file  
(b, c and d repeat for each of the pools in the file)
  - b. Pool Header Record
  - c. Loan Level Records for Forbearances (reported by issuer) only
  - d. Pool Trailer Record
  - e. File Trailer, final Record in the file.
- (4) Data in the layout is provided when available. If a data item is not available for a particular field, blanks will be output for that field, or have a code value for “unavailable” or “unknown”. For some fields on the “F” record, the data is subject to the availability of the data on the issuers’ servicing platform. The user should not expect that all fields will be reported all the time for all forbearance records. Field descriptions are provided for each record type, and contain additional detail.
- (5) The file contains records for Ginnie I pools and Ginnie II pools, to the extent the issuer has reported loan forbearance data.

- File Name: "GNMA\_MBS\_LL\_XXX\_CCYYMM" where XXX is MON for the monthly disclosure of supplemental loan forbearance information, and CCYYMM is the same value as "As-of-Date".
- File Number: Number from 001 to 999 if more than one file is produced in the period.
- File Correction Flag: Y (correction) or N (original) to indicate if this file is a correction of an earlier version of the same file
- As-Of Date: Reporting Period of the data in the file
- Date File Generated: The date the file was created

- Record Type: "P" for Pool Header
- CUSIP Number: A nine character unique identifier for the MBS security for the pool.
- Pool ID: The Ginnie Mae Pool identifier; the number assigned by Ginnie Mae at pooling to the pool.
- Issue Type: The one character issue type for the pool (X, C, or M).
- Pool Type: The two character pool type for the pool (see Ginnie Mae Guide, Chapter 1).
- Pool Issue Date: The date the given pool was issued (CCYYMMDD).
- Issuer ID: The four-digit identifier for the pool's issuer. This will be blank for Multi-Issuer Pools.
- As-Of Date: Reporting Period of the data in the file.

1. Record Type (F): An identifier for the type of record; "F" for Loan Level Forbearance record
2. Pool ID: The Ginnie Mae Pool identifier; the number assigned by Ginnie Mae at pooling to the pool.
3. Disclosure Sequence Number: An internal sequence number associated with the particular disclosure record. This will be the same disclosure sequence number for the loan that is used in the regular loan level disclosure. This forbearance record is a "supplement" to the regular disclosure record.
4. Issuer ID: The number assigned by Ginnie Mae to the MBS issuer organization.
5. Number of Months Forbearance: The number of months forbearance (the forbearance term) based on scheduled installments, as reported by the issuer. This field will be blank if not available.
6. COVID Flag: Values are Y = COVID related; N = Other type of forbearance not COVID related; U = Unknown. Ginnie Mae issuers report all active forbearances and to the extent available a flag indicating that the forbearance is specific to COVID circumstances or not. Will be "U" if not available.
7. Begin Date: The scheduled installment (per the loan's amortization schedule), that the forbearance begins. Will be blank if not available.
8. End Date: The scheduled installment (per the loan's amortization schedule), that the forbearance ends. Will be blank if not available.
9. Forbearance "Exit" Code:
  - 1 = Lump Sum Repayment Plan
  - 2 = Installment Repayment Plan
  - 3 = Partial Claim or Deferral
  - 4 = Loan Mod/Loss Mitigation/Combo
  - 5 = Loan Paid Off
  - 6 = No Workout/No Loss Mitigation
  - 7 = Other Type of Workout Plan
  - 8 = Unavailable: This is used where there is a Forbearance Exit, but no code was available
  - 9 = Cancelled; Loan Remained Current
 This data element will be blank/empty if the loan is not exiting forbearance this reporting period. A blank means there is no Exit.
