#### Introduction:

The purpose of this file is to provide users/investors with Mortgage Backed Securities (MBS) Single Family Loan Payment History data. For each active loan, a loan record will be available with data from each of the past 24 months of loan payments while in the Ginnie Mae pool. This layout applies to Single Family Loan Payment History file with Issuer-Reported data. The file will be produced monthly, beginning in June 2021.

#### Format:

**Bar Delimited** The format of the records in the file is vertical bar delimited "|". This is the same overall format used for the records in the Loan Level Disclosure Files, Forbearance Loan Level File, and Loan Level Liquidations File.

**Field LL-3 Disclosure Sequence Number** is common to the loan level records in this Payment History File, the Loan Level Disclosure File, the Forbearance Loan Level File, and the Loan Level Liquidations File. For a given loan level record, if the same Disclosure Sequence Number is in all four files, it can be used to "join" the records, providing the user a unified dataset of disclosure information about the loan.

**Field LL-5 Months Delinquent** is a "recurring" field in the record, with a maximum of 24 occurrences. Each occurrence (2 position bar delimited) represents a Ginnie Mae Report Period. The current (most recent) Report Period is in the left most position, followed by previous report periods, in sequence (oldest Report Period to the right) as applicable to the loan. If the loan has less than 24 months of history, only the actual occurrences of payment history are provided.

- Files will contain one Header Record ("HH"), one Pool Header Record per pool (PH), multiple Loan Payment Records ("LL"), Pool Trailer Record per pool (PT), and one Trailer Record ("TT").
- All records are sorted first by Pool ID and then by Disclosure Sequence Number and are listed in ascending order.

**"24 month" record:** This record provides 24 Report Periods of payment history. For the current (most recent) Report Period, the loan is current "00". In Report Period 24 the loan was current "00". For the most recent 8 Report Periods the loan has been current. In Report Period 9 the loan was one month delinquent, prior to that two months delinquent, prior to that three months delinquent, and prior to that five months delinquent. The change to five months delinquent from 11 months delinquent indicates that the borrower made 7 payments in Report Period 12. Prior to this the borrower was increasingly delinquent.

**"6 month" record**: This record provides 6 Report Periods of payment history (loan has been in the Pool for 6 Report Periods). For the current (most recent) Report Period the loan is three months delinquent. Prior to that two months delinquent, prior to that one month delinquent, and current for the prior months. The loan has become increasingly delinquent.
